**RULES & REMINDERS**

These are AQHA approved shows and follow rules in the AQHA Handbook. It is the responsibility of the exhibitor to know the rules. The following are reminders:

1. Horses: Registration papers or photocopies must be shown.
2. **Membership:** Exhibitor must have current AQHA membership card or purchase at show. Management will inspect the card.
3. **Youth** is 18 years of age or under as of January 1, 2009. **Youth/Novice Youth must** have AQHA Youth/Novice Youth card or purchase it at the show.
4. Stallions are NOT permitted in Youth classes.
5. **Amateurs/Novice Amateurs** must show **Valid Amateur / Novice Amateur Card** or apply at show. Amateurs must comply with ownership rules.
6. **Permits** as applicable per AQHA rules re showing non-owned horse are required and must be provided to Show Management. (Note recent AQHA rule changes re ownership / relationship of owner and exhibitor).
7. **Leases** as applicable per AQHA rules re showing non-owned horse are required and must be provided to Show Management. (Note recent AQHA rule changes re ownership / relationship of owner and exhibitor). Leased horses are eligible for Year End Awards with MQHA

**Fees, Stalls and Info:**

1. Hay and feed will not be available for sale. Bedding is available for purchase, from PLP staff for \$6.50 per bale or you may bring your own Shavings or Chips **only**
2. **Waiver:** You are required to sign a waiver stating sponsors, organizers, staff, MQHA, AQHA, do not assume responsibility for accident or illness to horses, attendants, riders, spectators, or others on the property or loss of / damage to equipment or personal belongings and that you assume all risks.
3. **Fees:**
  - a. Box Stall \$60.00; Straight \$40.00; Grounds fee \$30.00/day for horse not in stall.

  - b. Tack Box \$50.00; Tack Straight 40.00
  - c. Electrical - Trailer hookup \$55.00
  - d. Office Fee: \$15.00 per horse per show. Class fee: \$12.00 per class. **Please note HST will be charged on all show fees.**
  - e. Back numbers: \$2.00 If using own number register early so it is not assigned to another entry. Once assigned they will not be changed.
  - f. Drug testing: \$3.00 per horse per show.
  - g. Non AQHA class fees/rules (see entry/futurity form)
  - h. If exhibitor shows in Performance class, they will be able to enter the coinciding halter class for **Free**
  - i. Anyone wishing to participate in the Walk Jog classes may **NOT** lope on the grounds
  - j. There will be a Mock HUS & WP Class run before Class #54 & 302 with a \$5.00 fee proceeds will go to the Youth Association, Pay at the Ingate

**NEW FOR THIS YEAR: Payment arrangements must be made with the office upon registering for classes the night before the show begins**

**Cheques payable to Maritime Quarter Horse Association** No charge for scratched class if office is notified before class. Bills to be paid cash or cheque before leaving. Entries requested by September 1. A complete entry includes all classes entering, copy of horse registration papers, exhibitor AQHA ID card, and a waiver.
